NCPG Launches Third-Party Casino Exclusion

The National Council on Problem Gambling (NCPG) today announced the launch of *Third-Party Casino Exclusion*, which will bar 28,661 persons who are undischarged bankrupts as well as recipients of Public Assistance and Special Grant from entering the casinos.

Third-Party Casino Exclusion will cover undischarged bankrupts, as well as households under Public Assistance and Special Grant₁. They will be automatically excluded from the casinos. While the NCPG would be sending out letters to inform excluded individuals, receipt of such notification is not required for the exclusion to be in effect.

The exclusion will continue until the person is either discharged from bankruptcy or when the household is no longer on the Public Assistance or Special Grant scheme. The NCPG has statutory powers under the *Casino Control Act* to exclude individuals from entering the casinos in Singapore.

The NCPG has designed an online system accessible from the NCPG website (www.ncpg.org.sg) for the public to log in with their SingPass ID to check if they are subject to active casino exclusions.

¹ The Public Assistance / Special Grant scheme is a social assistance programme funded by the Government. It assists those who are unable to work owing to old age, illness or disability and who have no means of subsistence, and little or no family support.



The NCPG, said: "The Third-Party Exclusion from the casinos is the final part of casino exclusion measures to be implemented by NCPG. The Third-Party Exclusion protects those who are already financially vulnerable."

Aside from *Third-Party Casino Exclusion*, the NCPG has also launched Family Exclusion in April 2009, which empowers a family that is adversely affected by a problem gambler to exclude the person from the casinos. A third type of exclusion, Self-Exclusion, was recently launched on 26 November 2009, to give individuals the choice to exclude themselves from the casinos if they assess themselves to be prone to compulsive and excessive gambling. As of 6 December 2009, there are 19 orders issued for Family Exclusion, and 56 applications for Self-Exclusion. 
About the National Council on Problem Gambling (NCPG):


ANNEX 1: BREAKDOWN OF FAMILY EXCLUSION (AS AT 6 DEC 09)


ETHNICITY OF RESPONDENTS

AGE RANGE (RESPONDENTS)










ANNEX 2: BREAKDOWN OF SELF-EXCLUSION (AS AT 6 DEC 09)














ANNEX 3: EDUCATIONAL PROFILE OF SELF-EXCLUSION APPLICANTS (AS AT 6 DEC 09)
