

## Consolidated Application for Self-Exclusion (Organisation-Facilitated Declaration Form)

**NOTE:** This form accompanies the submission of the Consolidated Application for Self-Exclusion (Online) and is not for use on its own.

### Declaration by Applicant

By signing this form, I declare that I understand and agree to the following terms and conditions:

1. I confirm that my employer/organisation representative has explained the following terms and conditions to me and I have provided consent for this application voluntarily. I understand that:
  - a. My Self-Exclusion(s) takes immediate effect upon the submission of this application online.
  - b. My Self-Exclusion(s) will remain in force until such time that the National Council on Problem Gambling ("NCPG") revokes it. The NCPG may revoke my SE —
    - (i) Upon my application for revocation. I agree that I can only apply for revocation after a minimum period of 12 months has elapsed since the date my SE took effect.
  - c. When I apply to revoke my Self-Exclusion(s), the NCPG may, as a condition of revoking the SE(s), require that I:
    - (i) Participate in a programme of counselling, rehabilitation or special education; or
    - (ii) Undergo an assessment of harm from gambling, including a clinical assessment if necessary, by a suitably qualified person appointed by the NCPG for this purpose, or any combination of the above.

### Self-Exclusion (Casino)

- d. If my Self-Exclusion has come into force, I will be banned from entering or remaining on, or taking part in any casino gambling or promotional game on all casino premises.
- e. The NCPG will disclose my self-exclusion status to casino operator.
- f. Any entry levy that has been paid by me is not refundable, in whole or in part, under any circumstances.

### Self-Exclusion (Gaming Machine Rooms)

- g. If my Self-Exclusion has come into force, I will be banned from entering or remaining in, or taking part in any playing of a gaming machine in, all gaming machine rooms (except entering or remaining in any gaming machine room to perform defined work<sup>1</sup> within the room).
- h. The NCPG will disclose my self-exclusion status to every gambling operator who is authorised by a licence under the Gambling Control Act 2022 to conduct gaming involving gaming machines installed in a gaming machine room.

### Self-Exclusion (Singapore Pools)

- i. If my Self-Exclusion has come into force, I will be banned from engaging in all manner of general remote gambling<sup>2</sup>. For example:
  - (i) If the Applicant has an account with Singapore Pools at the point of submission of this application, he/she will not be able to access Singapore Pools account-related services after his/her SE takes effect; and

- (ii) If the Applicant does not have an account with Singapore Pools at the point of submission of this application, he/she will not be able to open an account with Singapore Pools after his/her SE takes effect.
  - j. The NCPG will disclose his/her self-exclusion status to every gambling operator who is authorised by a licence under the Gambling Control Act 2022 to provide facilities for general remote gambling.
2. For the purposes of this application, I consent to the NCPG obtaining my necessary particulars from the relevant authorities.
  3. I understand that legal action may be taken against me if I have given any false information in this application.
  4. I understand that by providing my contact information, I consent to the NCPG contacting me regarding my Self-Exclusion(s), responsible gambling practices and research.

<sup>1</sup> Under section 153(1) of the Casino Control Act 2006, “defined work” means, in relation to a gaming machine room of a gambling operator —

- (a) to deliver any goods, provide any services or perform any work (whether as a contractor or an employee) that is connected to the business, undertaking or work of the gambling operator carried on at the gaming machine room;
- (b) to seek a contract of employment or contract for service with the gambling operator; or
- (c) to execute an order of a court or a direction given by or on behalf of a public officer or a public authority in exercise of a power under any written law.

<sup>2</sup> Under section 11(1) of the Gambling Control Act (GCA) 2022, “general remote gambling” means remote gambling that is none of the following:

- (a) on-course betting;
- (b) off-course betting;
- (c) gambling using a gambling service authorised by a class licence;
- (d) gambling using remote communication at premises as a customer of a place-based gambling service provided at those premises on the basis described in paragraph (c) of the definition of “place-based gambling service” in section 3(1) of the GCA.

- It cannot be cancelled for 12 months.
- It continues even if I change jobs or leave Singapore.
