  - c. Pursuant to Clause 1(a):
    - i. I consent to the National Council on Problem Gambling (NCPG) disclosing information to the Singapore Pools on whether I am a subject of Self-Exclusion from all Singapore Pools Accounts upon receiving my completed application form.
  - d. Pursuant to Clause 1(b):
    - i. I consent to the NCPG disclosing information to the Private Club(s) on whether I am a subject of Self-Exclusion from all Jackpot Machine Rooms, upon the request of the Private Club(s) at the point of my entry into a Jackpot Machine Room.

- ii. I understand that Private Clubs operating Jackpot Machine Room(s) will enforce the Self-Exclusion.
  - e. I understand that my Self-Exclusion will stay in force until I apply to revoke it. If I decide to revoke my Self-Exclusion, I agree to apply to revoke only after 12 months from the date of my application for Self-Exclusion.
  - f. I agree that NCPG shall not be responsible for any loss or damage which may result from my application for Self-Exclusion and the enforcement of the Self-Exclusion.
2. I understand that legal action may be taken against me if I have given any false information in this application.
  3. I understand that NCPG may use my contact information provided above to inform me of any relevant updates on matters relating to my Self-Exclusion.
